6. New Business

- a. Policy Updates
 - i. Check online for Area Alignment LSC has changed for Area.
 LSC Area D (newly aligned mostly East Texas)
 - ii. Private schools will now follow their UIL Classification based on enrollment. Charter schools still follow LSC or SSC distinction based on Public school enrollment. Ex – all Charter in Tyler ISD will compete in LSC. You can apply for a variance to compete in SSC.
 - iii. All-Region Entry Fees increase
 - iv. Discussion of raising entry fees to \$15 per student plus a once a year campus fee of \$50 for the first round of auditions. There was also discussion to clarify that LSC and SSC directors would pay the \$50 campus fee for All-Region auditions and pay again for Honor Choir auditions. Many other regions already do this. There were also concerns about middle schools being able to afford to enter students.

A motion was made a seconded: Raise the entry fee for high school to \$15 per student plus a \$50 campus fee per track. Also, raise the entry fee for middle school to \$14 per student with no campus fee. This was seconded and passed unanimously.

b. Honor Choir Proposal and discussion

Amy McMichael brought forth a proposal that we separate Honor Choir auditions from the LSC/SSC all-region auditions. The rationale is that All-Region entries for the current year only increased by 76 entries. Compared to last school year, total entries for All-Region and Honor Choir were 119 fewer. This is not serving our students. Most of our beginning high school choir students are not ready to learn the advanced music of the LSC/SSC All-Region track yet. Honor Choir music serves them better. Also, some of our vocal division money loss was due to no entries for an Honor Choir audition.

A motion was made a seconded: Separate LSC/SSC All-Region auditions from Honor Choir auditions. Go back to the way it was prior to this school year. This was seconded. Discussion: Many directors are in agreement that most non-varsity high school students are not ready for the advanced audition. Some directors shared that some of their students were "disgusted" that they only made the Honor Choir when in

years past they were excited when they made it into the Honor Choir at its own audition.

Vote: for-11 opposed-3

- c. Possible combination of Region Clinic and Concert with Region 4 (LSC Only) This was not discussed.
- d. Conflict with November 9 for HS Clinic and Concert discussion.

This is a protected date for strings and mariachi. We can apply for a variance. Discussion of possibly Monday, October 28th for the high school Clinic & Concert. Start at around 10 or 11am and have the concert in the evening.

Motion was made to combine the middle school and high school Clinic & Concert. Seconded

Discussion: It's a long day for middle school. It's good for middle school to see the high school choirs.
