- b. All-State music packet is more tiered this year and seems to offer better choices for a Region Concert. Repertoire lists by round will be sent this summer. All music must be certified by audition or performance. Continue to check the TMEA website for errata.
- c. Honor Choir proposal see details in the updated handbook. In a nutshell, there will be one high school region audition. The top chairs will be placed in the Region Mixed LSC or SSC Choirs. The next chairs will be placed in the Honor Choir. Singers who make it into the Honor Choir will have to learn the music for the Clinic/Concert.

An argument for the proposal – this will keep our numbers for apportionment from dropping. Apportionment is based on the first round of auditions. This is mainly an LSC issue.

An argument against the proposal – programs with large numbers of non-varsity or beginning level students benefit more from Honor Choir being a separate audition. The region music is too advanced.

A motion was made to accept the proposal along with an amendment that the audition would consist of 4 "All-State track" pieces along with 2 Honor Choir pieces. This motion was rescinded.

A motion was made to accept the Honor Choir proposal and only head directors can vote. This motion was rescinded.

A motion was made to accept the Honor Choir proposal as written for 2023-2024. Seconded. Tie vote: 6 for and 6 against.

Discussion: there is nothing in the handbook that limits votes.

A motion was made to revote to include all membership to accept the Honor Choir proposal as written. Second. 14 for and 8 against. The motion passes.

- d. Conflict of November 11<sup>th</sup> for the comparable High School Clinic & Concert date. It is a protected date from TMEA for area jazz, orchestra, and mariachi judging. A motion was made to submit a variance to TMEA to keep the High School Clinic & Concert on November 11<sup>th</sup>.
- e. A motion was made for the High School All Region auditions to be only All Region music. All Honor Choir music would be learned after the auditions. Second. Passed unanimously.
